



## GENERAL INFORMATION

You are invited as local and regional fine artists, designers and craft artists to show your artwork at our annual *Christmas at Crossroads – The Gift of Art*. We are looking for fine art, small prints, fine crafts, mixed media, sculpture, high quality local hand-crafted gifts and original tree ornaments.

This year we are bringing back “artist booths,” providing artists an opportunity to display all of their artwork together on a single or double panel. Artists are encouraged to be present during both the opening reception and First Friday reception and available to talk to patrons about their artwork. There is no fee for the booth spaces and artists who are interested may sign up for a full booth (2) 48” x 48” panels or half booth (1) 48” x 48” panel to display their artwork on a first-come-first-served basis. Sculpture stands are available for 3-dimensional artists. Please call Crossroads at (541) 523-5369 to sign up for a booth. Artists who wish to submit artwork to the show but do not want a booth space are also welcome.

In the interest consistency, artists will not decorate their booth and the Gallery Committee reserves curatorial rights for the overall appearance of all displays in the Gallery.

## ENTRY CRITERIA

Christmas at Crossroads is open to professional and amateur artists aged 18 and older. All work must be original. Paintings must be dry and appropriately presented, mounted or framed, ready to hang with screw eyes and wire attached. No saw tooth hangers will be accepted. Prints should be appropriately covered to protect artwork. If this is your first time entering a Crossroads open show and you have questions regarding your work, please call the gallery for clarification at 541-523-5369.

Work submitted must be of original design and of high quality. Work that is manufactured, imported, reproduction made from kits or under the supervision of an instructor is not eligible. The Gallery Committee reserves the right to refuse any artwork which is inconsistent with the general quality of the exhibit.

We are able to accept a larger number of smaller pieces for the December show. If there are more entries than space allows, it may be necessary to limit the number of works per artist shown. All reasonable care will be taken when handling artwork received.

There is no entry fee for this show and all items must be available for sale. There is a 30% commission for Crossroads member artists and a 40% commission for non-members. It is the artist’s responsibility to check inventory throughout the month as work sells and space becomes available.
